## Shipping Conditions

Cancellation Notice:	NYSW 37411-13 cancels NYSW 37411-12 in its entirety. Rates are subject to change or cancellation on 15 days notice.
Currency:	Rates stated in US funds
Equipment:	1) Locomotives when moving on their own wheels 2) Railroad / Private marked railcars (all types) Shipper owned or leased equipment (PVT) Railroad owned equipment (RR)
Fuel Surcharge:	Subject to Mileage Based Fuel Surcharge (MBFSC)
Inspection:	All waybilled locomotives on own wheels moved dead-in-tow will require Mechanical Department inspection prior to NYSW accepting for movement. Locos must have either alignment control couplers or coupler limiting blocks in order to be moved in regular freight train service.
Liability:	1) Shipment of locomotives requires shipper to sign full release of liability before shipment is accepted by NYSW. 2) Shipment of private cars may require shipper to sign full release of liability before shipment is accepted by NYSW.
Mileage Provisions:	No mileage allowance will be paid on shipper owned or leased equipment.
Payment Terms:	Prepaid/Collect with approved credit prior to shipment.
